4.The trust has been created the following objects.



i) To Sponsor Religious Functions of all the religions, cast & creed.

j) To start and maintain Goshala.

5. IN PURSUANCE OF ABOVE OBJECTS THE TRUST MAY:-

a) Open, take over, establish, conduct, maintain, magnate equip, transfer, close down, dispose of Nursery School, primary Schools, High Schools, Colleges, Training Centers and other related institutions , hostels, orphanages, destitute homes, research centers, and other related institutions.

b) May acquire by purchase, lease, mortgage, loan, gift, grant, legacy, bequeathal, exchange the rights, privileges or otherwise from any person, company, Government, Institutions or anybody whatsoever moveable or immoveable properties of all descriptions deemed necessary or useful any purpose of the trust.

c) May erecting building, workshops, quarters, for staff members or any types of building or structures whether to further any purpose of the trust and to maintain develop, alter, repair demolish, or reconstruct the same or any portion thereof.

d) May take or receive any gifts, whether money or property moveable, donations in the forms of debentures, stocks, shares or securities in any company or society whether incorporated or not or foundations and whether subject to any special trust or not or any one or more of the trusts, or by gifts by persons, and take steps legacy, bequeathal, will or foundations, and take steps for securing of such contributions for founds and from time to time deemed expedient with in or our side Indian.

e) May alienate by way of sale, mortgage, release, loan, charge, hypothecation, pledge, exchange, giving subscriptions, contributions hiring out, gift or otherwise with or without security to properties on funds of the trust or any portion or portions thereof including the making or giving subscriptions, contributions assistance, pecuniary or otherwise to educational or charitable or other institutions, bodies, or person as from time to time deed necessary or expedient.

f) May lend money free or at interest invest, lay aside deposit, in bank or otherwise deal with money or funds of the Trust not immediately required for the objects of the trust and to subscribe for purchase, acquire, hold sell, endorse and negotiate in every way, debentures, stock, shares and securities of every description in the money market in conformity with the provision contained in Section 20 of the Indian Trust Act 1892.

g) May borrow or raise funds with without security in any member the trust may think fit and repay the same.

h) May negotiate with and enter into agreement with any Govt. or authority whether central, state, corporation, Board, University or other public or Private bodies or any individual as may deem conducive to the promotion of accomplishment of the objects, of the trust or any of them and to apply for obtaining, collecting, receiving or receiving from any such Government or Authority or body such grants, allowances, rights, concessions and privileges as may seem to comply with and utilizes the same.

i) May use all income from the Nurseries, Schools, Training Institutions, Technical Institutions, and collages and other allied Institutions and from the property moveable or immoveable whenever believe for the object of the trust.

May in general, do or cause to be done all such acts or things as shall be conducive to the welfare of the trust, provided such things or acts be not contrary to. Or inconsistent with the spirit and principles of law under which the trust has been established.

6.The profits, income and property of the Trust will be applied solely for the promotion of the objects of the trust, as set forth above and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses or otherwise however by way of profit to any person provided that nothing herein contained shall prevent the payment in good faith of remuneration of any officers or servants or employees of the Trust or Other persons in persons in return for any services rendered to the Trust.

7. The above named Trustees shall be first Trustees of the Trust

8. The number of Trustees shall be not less than 2 . The trustees may co-op others as trustees. Any Trustee may resign by giving notice in writing to his C-trustees any trustee shall also cease to be a trustee, if requested in writing by majority of the trustees. Appointment of Trustees either to fill up vacancy or as additional trustee shall be by resolution of majority of the Trustees. In case of vacancy of a Trustee the other Trustees can Co-opt a person.

9. If any vacancy arises in the Board of Trustees on account of death, incapacity or persistent neglect of any Trustees or if a Trustee resigns his office or Trustee be adjudged insolvent or if a trustee is found quality of any Criminal offence involving moral turpitude then such vacancy shall be filled up by the remaining Trustees by a majority vote. In the case of a tie the managing trustee of the Trust for time being shall have a casting vote.

10. Sri. D, YOGESH shall be the first managing Trustee. Managing positions in the Trust Shall be changed as per the Majority of Trustees Decisions.

11. Two Trustees shall from the quorum for board of Trustees meetings. Decision Shall he taken by the vote of simple majority of the members present and voting.

12. The Trustees, subject to the terms of his deed, shall have authority and power from time to time make, after and rescind rules and regulations for management and administration of the Trust shall be decided by majority of Trustees.
